Industrial action update Our local Industrial Action Short Life Working Group met again this afternoon. We are finalising the FAQs we mentioned last week, and we intend to share this with you tomorrow. We understand many of you have questions about the forthcoming action and the impact it will have; we are grateful for your patience.

When industrial action was first announced, we asked all services to pause the processing of any **new** requests for annual leave during the strike dates **only** (12-15 July). We are taking a cautious approach to planning for industrial action and, as a consequence, have decided that this pause remains in place; for clarity, it does **not** affect any leave on these dates booked and confirmed prior to 13 June 2023. This is being kept under review and we will inform you, via this brief, when the pause can be lifted.

Vapes disposal All vapes - whether reusable or single use - contain a lithium battery as the power source. Lithium batteries are notorious for causing fires when they either overheat or are broken - it is estimated vapes cause one fire **every day** in the waste industry alone. **Under no circumstances should vapes be disposed of in general waste, recycling, or clinical waste bags if the battery is still intact.**

Whether it is your vape or a device you've found on one of our sites, the battery should be removed and placed into the nearest battery collection point. The rest of the vape can then be disposed of in general waste bags. If batteries cannot be removed, then the whole device should either be placed into a battery collection point, or boxed up and labelled as W.E.E.E. Recycling, Central Stores.

Be careful when posting information Even though our work is increasingly digital, as an organisation we still post thousands of items each day. Sending information to the wrong person can cause distress and harm. Simple mistakes like picking up two letters instead of one, or mis-addressing an envelope are easy to make if you're working your way through a stack of outgoing mail. Asking a colleague to double-check the right letter is in the right envelope before you post them, using place-markers to help you spot where one letter ends and the next one starts, or dividing envelopes are all ways we can prevent mistakes from happening.

It's more common than you might think for two people with the same name to be receiving treatment or care at the same time; sometimes even in the same service. When sending information out, check names and addresses using more than one identifier (for instance name and CHI) to reduce the risk of information for one person is sent to someone else. Finally, if you send a letter and it ends up at the wrong address, the person who receives it by mistake can return it without opening it if you put a return address on the back. If you're concerned about identifying a letter from the NHS – for example, because the information is sensitive, or the person receiving it is in a vulnerable situation - double envelope the contents and put the return address on the back of the inner envelope.
